

## RETURNABLE REELS

1. All reels, spools, and returnable pallets ("Packaging Material") are the property of Seller and are to be returned to Seller or its designated agent\* at the location from which they came, unless otherwise specified.
2. Buyers are requested to contact Seller's designated packaging return agents for specific instructions prior to return of the Packaging Material.
3. Packaging Material will be picked-up within 8 working days of contact with the designated packaging return agent. If you have any issues regarding service, please contact your designated Essex customer service representative.
4. The preferred method for storing Packaging Material must be indoors in a cool, dry, place, and care should be observed in handling and shipping.
5. If Packaging Material cannot be stored indoors, then it must be stored in an enclosed, protected container.
6. In the event these instructions are not followed for the return of Seller's reels, Seller reserves the right to charge for any excess costs incurred as a result thereof.
7. **Seller reserves the right to charge for Packaging Material not returned within 6 months or which are damaged as the result of improper handling or storage.**
